

Online Zoom Worship Services

Our Sunday morning online worship services via Zoom have provided us with the means to stay in touch with each other and to worship together during this time of COVID-19. We miss the in-person togetherness, but we can still connect thru our Zoom worship services and other meetings. If you are not attending our Zoom services, we want you to know that we miss your attendance. These Zoom services are beneficial in keeping us connected during this time of separation. So, if you have not joined with us for an online worship service, we would encourage you to do so and get reconnected to your congregation. Also, you will most likely meet new friends, as well as old friends, from other parts of the United States that have been joining us for worship. At the end of our services there is time to share and chat with each other about what is going on in our lives as well as to share joys and concerns.

If you are having trouble connecting or gaining access to these online services, please call Gary Chatburn for assistance. If you do not have computer or phone devices, or your computer hardware and other devices are not adequate, you can talk to Gary and he can check on possible solutions for you. We want to be able to include everyone in our congregational worship and activities.

From Your Facilities Management Team

Seasonal Overnight Shelter: The City of Fort Collins has elected to not use our facility this year for the Seasonal Overnight Shelter. The city has leased vacant space in the Larimer County Food Bank facility for this purpose.

Church Lawn Irrigation System: The sprinkler system was recently drained and the sprinkler headers blown out in preparation for the winter months. During the sprinkler system blowout, it was noticed that there were several

sprinkler heads that were not functioning properly and will need to be inspected next spring.

Building Projects: All building projects have been placed on hold until further notice. With the COVID-19 pandemic and other factors, it was determined that it would be wise not to proceed with any major projects, unless absolutely necessary, until it can be determined how we will be functioning as a congregation after the pandemic.

Maintenance of Church Facilities: Several building maintenance items have been recently completed: (1) The Activity Center floor carpet was cleaned. (2) The basement vinyl tile floor was scrubbed, recoated with wax, and buffed. (3) The Activity Center elevator and the foyer elevator were placed under a new contract with a new service provider. The first maintenance visit occurred a few weeks ago. The two elevators are due for state inspections in November. (4) The building furnaces were recently checked for proper operation with no issues found. Since the building is currently unoccupied, thermostats have been set to maintain sufficient heat for various areas of the building while trying to reduce utilities cost during the winter months.

Notes from the CFO's Desk

Contribution Receipts: Due to the COVID-19 pandemic and not meeting in-person, we have not issued contribution receipts for the 1st, 2nd, and 3rd quarters of this year. We will, however, be mailing year-end contribution receipts for the complete 2020 year to you by February 1, 2021. If you have any questions before then about your contributions, please contact Ruth Chatburn (970-833-0570) so she can assist you.

Contributions During the Continued Closure of our Facilities: Contributions have remained fairly stable with a slight dropping off in contributions the last couple of months. We are doing our best to minimize as much expense as possible and remain within our

budgets. We want to thank everyone for their continued financial support and let you know that we are very appreciative of the funds that are received each month.
