My favorite recitative and air of the *Messiah* is by the bass and the trumpet, Behold, I Tell You a Mystery and The Trumpet Shall Sound. I can hardly wait for these numbers that come near the end of the performance. I can play these two pieces over and over and over. There is something about that trumpet that lifts me up when I am down and lifts me higher when I am up. As the trumpet goes up the scale so does my heart soar, and I believe that I can indeed be changed. What *mystery* there is in this promise! It doesn't make me incorruptible, as the words continue, and it is not about a final resurrection of immortality, as the sound penetrates my carefully built walls of invulnerability to grace. From Your Facilities Management Team

Seasonal Overnight Shelter: The City of Fort Collins has elected to not use our facility this year for the Seasonal Overnight Shelter. The city has leased vacant space in the Larimer County Food Bank facility for this purpose.

Building Projects: All building projects have been placed on hold until further notice. With the COVID-19 pandemic and other factors, it was determined that it would be wise not to

proceed with any major projects, unless absolutely necessary, until it can be determined how we will be functioning as a congregation after the pandemic.


Maintenance of Church Facilities: Several building maintenance items have been recently completed: (1) The Activity Center floor carpet was cleaned. (2) The basement vinyl tile floor was scrubbed, recoated with wax, and buffed. (3) The Activity Center elevator and the foyer elevator were placed under a new contract with a new service provider. The first maintenance visit occurred a few weeks ago. The two elevators are due for state inspections in November. (4) The building furnaces were recently checked for proper operation with no issues found. Since the building is currently unoccupied, thermostats have been set to maintain sufficient heat for various areas of the building while trying to reduce utilities cost during the winter months.

Contribution Receipts: Due to the COVID-19 pandemic and not meeting in-person, we have not issued contribution receipts for the 1st, 2nd, and 3rd quarters of this year. We will, however, be mailing year-end contribution receipts for the complete 2020 year to you by February 1, 2021.
