## "We Did It!"

Have a good time finding joy in service. We are on this adventure together in discovering new and exciting ways to express our stewardship of generosity. It is the foundation of Zionic enterprise.

As a team working on expanding our understanding of the Holy Spirit, we want to thank you for your consideration of and/or participation in the three sessions we have held so far. These were: "An Introduction to Our Present Understanding of the Holy Spirit," led by Brian Entwistle; "Centering Prayer," led by Sharon Troyer; and "An Introduction to Reike" led by Dick and Julie Foster.

As you know, the church is encouraged to "grow in spirituality." The three sessions offered were designed to help us expand our awareness of the Holy Spirit in our lives. We will continue to offer further exploration and discussion for personal and congregational spiritual growth. #### **Getting to Know You!**

## What drew Nancy Simon to the Fort Collins Congregation?

Was it the stories about camps and reunions that Nancy and Dick Zmyslony told? Or was it the kindness shown to her by the Gordier family when she stayed with them after she injured her shoulder in a car accident? Or was it simply the first invitations extended to her to attend and the urgings to share Sunday lunches with several of the members (you know who you are)? Was it the welcome that she felt from several of the families in the congregation, or was it the visits from Dave Simons and Brian Entwistle? Was it the helping hand that Max and Tom continue to lend since her shoulder is not as useable as she might like? Was it the football watching Sundays at the Kohlman's? Or was it Gary Gordier's administration that helped her in her survival and recovery from injuries in a car accident? All of these and many more influences were there before Nancy decided to be baptized in June of 2012.

#### What is Nancy's background?

She claims to be a farm girl from Wisconsin who "ran away from home in 2000." A friend lured her to Loveland where she worked in care of the elderly-first at Good Samaritan then at McKee before she branched out on her own. Nursing is her primary talent, but she has done many different jobs, including factory work and housekeeping. When Peggy Gordier was struggling to provide a comfortable solution for her parents in her home, Nancy came to their rescue, and she was exactly what was most needed. Most recently, her disabled shoulder has limited her in the type of work she can do. So she is driving for Good Day Pharmacy, which means that she is on call at all hours.

In high school, Nancy worked for Pinecrest as a housekeeper. The administrator there

suggested that she work with the dietary unit. Thus, when she graduated from high school, Nancy began working as a nurse's aide on the floors—even though the idea of death was difficult for her to handle. She has also lived and worked in Appleton and Madison, Wisconsin. She has followed the nursing line of work for over 30 years.

#### Where has Nancy volunteered?

Since Nancy's specialty is elder care, she naturally finds that hospice work is where she can best serve. However, she also has made it a point to keep up with individuals with whom she has shared homecare. When she was living in Appleton, she volunteered for AIDS projects. She has been exploring CDVR for vocational rehab to determine how else she might return to the medical workforce.

#### What draws Nancy back to Wisconsin?

Last year Nancy took the time to drive back to Wisconsin taking the scenic route and finding interesting "hole-in-the-wall" kind of eating places as she went. On her return trip she detoured via Minnesota and South Dakota where she visited Mount Rushmore and Wall's Drug.

She spent the time in Wisconsin visiting family and friends. She is the oldest of eight children, including a twin brother and a brother and a sister who are twins, as well as two other younger sisters, a brother, and another favorite baby brother, Bill. Her mom also still lives there. Although the family moved off the farm in 1964, Nancy has fond memories of milking and mucking as well as raising a baby calf named Corky that became a playmate even after he was grown to be a white-faced bull. She remembers that a lot of family that lived nearby and one Uncle's family would come from Milwaukee to stay in the summer time. Her grandmother would take her berry picking, and her homemade bread is still remembered. Her mom's mom made a special sausage when they butchered; it had quite a unique flavor that Nancy was surprised to find similar when served sausage made from elk meat.

Nancy lived for some time in Arkansas, and she also got a chance to attend the Balloon Fiesta in Albuquerque. She felt a special affinity to Gettysburg when she visited Pennsylvania. She felt like she had been there before.

## What are some things that you might not know about Nancy Simon?

She has a wicked sense of humor and she very much enjoys a good laugh. Her infectious laughter has attracted us all, at one time or another. She has an extensive collection of baseball caps from which she selects the appropriate one for any occasion. She really enjoys a "good burger" at either Five Guys or



Smashburger. There are two cats that live at Nancy's house—Tyson, on the right, who likes to be in charge; and Sam, who is

the thinker and a bit shy. The "boys" allow her to share the apartment with them (they are in charge).

Nancy is a recovered alcoholic; 28 years sober. Her cousin urged her to take a look at herself and join an outpatient treatment program in Appleton, which she did.

#### What does Nancy do for fun?

Watching football is quite important especially if the game is with the University of

Wisconsin, the Green Bay Packers, Notre Dame, or the Colorado Buffalos. She has been known to watch golf or the food channel with Guy Fieri when he restaurant hops. She says that she enjoys seeing what HDTV has to offer. She likes to cook and will make up a big pot of soup or a roast to last through the week. She also likes chili, the hotter the better. Nancy has adapted well to the Colorado outdoor lifestyle; she likes to be outdoors and to walk. Nancy finds that Rocky Mountain National Park is a place of solace and visits when time allows. She enjoys viewing the park's wildlife—particularly the elk. —Beverly Doig, reporter

## USA National Conference Recommends Policy Changes

#### First Presidency and Council of Twelve Will Have to Approve before Implementation

The Community of Christ USA National Conference was held April 19–21. After a threeyear consent-building process of study, dialogue, and prayer, members from across the nation gathered at Community of Christ Auditorium in Independence, Missouri, to address two issues: same-sex/gender marriage where legal, and covenant commitment services where marriage is not legal; and ordination of people regardless of sexual orientation.

After hearing multiple perspectives, the USA National Conference, by more than the required 67-percent majority, made the following recommendations to the Community of Christ First Presidency and Council of Twelve Apostles:

•The 2013 USA National Conference recommends the sacrament of marriage be extended, where legal in the USA, to persons of the same sex/gender. Thus the 2013 USA National Conference recommends a change to the current policy for the USA on the sacrament of marriage; and

•The 2013 USA National Conference recommends that a church-recognized way for two persons of the same sex/gender to publicly express their covenant to each other be made available in places in the USA where marriage is not legal. Thus, the 2013 USA National Conference recommends a change to the current policy for the USA regarding samesex/gender covenant commitment services where marriage is not legal; and

•The 2013 USA National Conference recommends allowing a priesthood call to be processed according to established procedures regardless of sexual orientation, including a person in a monogamous, committed, samesex/gender relationship (e.g., legal marriage, civil partnership, covenant relationship) in the USA. Thus, the 2013 USA National Conference recommends a change to the current policy on ordination for the USA.

The First Presidency and the Council of Twelve will need to approve policy revisions recommended by the USA National Conference. To develop, approve, and implement interim policies can take up to one year. Any policy changes will pertain only to the United States of America. Other nations will continue to abide by existing church policies.

## Faithful Disagreement Definition and Principles

World Church Leadership Council, March 2013

#### Definition

Faithful disagreement is defined as actions and/or responses by a person holding a different view about a specific policy, belief, principle, or other position of Community of Christ. This disagreement with a Community of Christ position or direction is helpful, responsible, faithful, and bounded by loyalty and commitment to the identity, mission, message, and beliefs of Community of Christ. A person who faithfully disagrees is welcome to share about the church position with which she or he disagrees. The intent of the sharing is to improve the overall faithful response of the church to God's intended direction without classifying others as unfaithful.

#### **Principles**

- Community of Christ's Enduring Principles— Blessings of Community, Worth of All Persons, Responsible Choices, and Unity in Diversity—allow for faithful disagreement.
- 2. The commitment, in general, to the overall identity, mission, message, and beliefs of Community of Christ may serve to keep a person in the faith community even when that person strongly disagrees with a particular position. One's love for the faith community is stronger than any particular disagreement.
- 3. Holding a differing view from the Community of Christ position on a specific matter does not lessen in any way a person's participation as a faithful, generous, committed, and responsible disciple. Nor does having a differing view impact a person's eligibility to hold a priesthood office or partake in the sacraments.
- 4. A person with a differing viewpoint on a particular position is to be respected by the body. She or he may share a viewpoint as a personal opinion during discussions, meetings, training, and other conversations where it is suitable to share personal opinions.
- A person is not to be excluded by a congregation or mission center because of holding a differing viewpoint on a specific Community of Christ position.
- 6. A member or a priesthood member with a differing

viewpoint is not to use public-ministry opportunities to speak against the identity, mission, message, or beliefs of Community of Christ. Nor should a member or priesthood member publicly criticize the Community of Christ stance on the particular position with which the person disagrees. Public ministry must focus on proclaiming the good news of Jesus Christ in ways that align with Community of Christ identity, mission, message, and beliefs.

- 7. Agreeing with Community of Christ positions, official and unofficial, is not a test of faith for priesthood, members, and friends.
- 8. A person cannot ignore policies because he or she disagrees with a particular policy. Ethically, administrators must consistently apply the official policies and procedures of the church.
- 9. At no time is any action that harms the body of the church considered in harmony with the principles in this document.
- 10. In seeking to create genuine signal communities, we listen respectfully to one another's viewpoints. In addition, we try to see from each other's perspective. We trust in each person's commitment to Christ and motivation to see the mission of Community of Christ flourish. We seek to celebrate our unity while learning from our diversity.
- 11. As a community that embraces Continuing Revelation, we strive always to remain open to the Holy Spirit. We understand that sometimes both individually and collectively we respond wisely to the Holy Spirit's guidance, and sometimes we do not fully understand. Through our vulnerability to the Holy Spirit, we trust God will continue to guide us in refining positions held by Community of Christ.
- 12. Various legislative conferences and consent-building methods used by Community of Christ, allow a person holding a differing viewpoint to continue to seek change to the position with which she or he disagrees.
