#### Rocky Mountain Mission Center Business Meeting October 22, 2022 Conducted via Zoom

Joel Cox, RMMC President, called the 2022 Rocky Mountain USA Mission Center Business Meeting of the Community of Christ to order at 2 pm MST. He welcomed everyone and thanked them for their attendance. He invited everyone to join in prayer as brother Bill Hyatt offered the opening prayer."

Joel offered gratitude to Richard Betts for attending the business meeting this weekend and stated he has been blessed by Richard's ministry of compassion and wisdom. A moment of Blessing was offered by Richard Betts with a video presentation entitled "For Those Who are Exhausted."

Joel introduced those who will be sharing in our business session.

- Alice Hyatt, who will be taking our minutes today.
- Richard Betts, Support Minister for the Western Field who is serving as parliamentarian as well as sharing with us in ministry and community.
- Bill Hyatt who offered our opening prayer.
- Monica Argotsinger will close our meeting with prayer.
- A special thank you to Melanie Grimes who is managing the technical side of things for us.

He also expressed appreciation for all the effort dedicated to planning and organizing this conference. This conference would not be possible without the love, dedication, and talent they joyfully offer.

Delegates were asked to turn to pages C1-2 in the Fall conference brochure to find the minutes of the 2021 Rocky Mountain Mission Center conference. Everyone was given a few moments to look them over. Joel asked for any corrections, additions, or modifications to the minutes. Only one correction on page 2 – to change Joe at the beginning of the paragraph to Joel. There weren't any other changes.

Joel explained that since this is a delegate meeting, only delegate votes would be counted. In order to determine the number of delegates present at this conference, he asked for a show of hands, and to keep them raised until he was sure all were counted. The Minutes were approved as corrected. He also stated that since there will be occasions when a show of hands is needed, everyone needs to turn on their video when voting is required.

Joel turned the chair over to Field Support Minister Richard Betts. Richard read a letter from Apostle Harmon and a message from President Veasey. After these greetings he proceeded with the sustaining of Mission Center Officers, beginning with the reading of the letter from Apostle Harmon appointing Sean Langdon to the office of Mission Center President, effective January 1, 2023. (Letter attached to these minutes.) Andy Horner moved to approve this appointment and received a second. There was no discussion and the motion carried.

Next Richard asked for a motion to sustain Joel Cox as the interim Rocky Mountain Mission Center Financial Officer. Shirley Remmenga moved to sustain and received a second to the motion. Motion carried.

Joel invited the delegates to turn to page A4 of the conference brochure and read his letter to the conference recommending that Travis Savage be sustained as our Invitation Support Minister. Kirk Bell made a motion to sustain this appointment and received a second. The motion was approved.

Next item was the appointment of the RMMC Leadership team as printed on page A5 and asked for a motion to sustain Monica Argotsinger, Jandy Barentine, Barbara Gardner, Bob Walker and Travis Savage as members of this team for 2023. He received a motion from Ron Argotsinger to sustain these appointments. A second to the motion was made and the motion carried. Joel expressed appreciation for the support of these ministers and friends in their roles in our mission center.

Delegates were asked to turn to Page A6 for consideration to sustain the Mission Center Council in 2023 and read the letter to the conference. This Council is the key group that advises the MC President and Financial Officer on issues affecting the mission, programs, finances, and ministries of the Mission Center. This Council consists of the pastors and the Leadership Team Members. Gail Sundell moved to sustain this Council and received a second. Joel asked for any objections. None were received and this was approved.

At this time, Joel directed attention to a letter on page A7, recognizing and honoring the following individuals for their service to our faith community: Travis Savage, Bob Walker, Monica Argotsinger, Jandy Barentine, Barbara Gardner, Melanie Grimes, Steve Holloway, Phyllis Modica, and Rebecca Russell. Reference was made to page A9 where Joel expressed appreciation to those ministers who have served as pastors, recorders, financial officers and administrative assistants in their respective congregations. In addition, he acknowledged Sandi Rickart who is our webmaster, Cherry Newcom and Naomi Barlow who are designated to train and prepare persons interested in becoming Registered Youth Workers. Delegates were reminded that there are many in the mission center who work with our children and youth, who offer traveling ministry, hospital and in home ministry, serve as camp directors, counselors and staff. Our congregations are blessed to have devoted and loving pastors, CFO's, recorders, historians, greeters, teachers and worship planners. These are the people; YOU are the people that give so generously and provide life affirming ministry. None of this works without you. Thank you for your loving, Christian discipleship.

Next on the Agenda was the proposed 2023 Budget found on page D1 in the conference brochure. Joel asked for a motion to approve the adoption of this proposed budget. Steve Schultz moved to approve and received a second. Joel stated as Interim MCFO he would attempt to address questions any might have. One question pertained to any compensation

that members of the leadership team might receive. Joel responded that they are reimbursed for any expenses they incur for the ministries they bring. There were no other questions and the 2023 Budget was approved by a show of hand as it is presented in the brochure.

Joel noted that financial reports are also provided in the "D" section of the brochure including the Auditor's report. He invited all to read these reports at their leisure to be informed about the ministries of the mission center. These reports require no action by the conference and are simply informational. He thanked Dave Simons for his extraordinary dedication to the MC and getting the audits done. His thanks included those who work on their congregational audits.

Now attention was directed to the Big Spruce campground. Reports are on page B2, and contain the budget, balance sheet, internal audit and financial report. The Big Spruce campground board ballot for Campground Board Members is printed on page B3. The names on this ballot are nominations for the Big Spruce Campground board for a term that will expire 12/31/2025. There are 3 openings and there are 3 individuals who have expressed interest in serving on the board. Joel opened the floor to additional nominations and none were made. Joel declared that Shyree Kirkpatrick, Bill Grimes and Kathy Stanford will serve on this board, with terms to expire on 12/31/2025.

The next item of business was the election of World Conference delegates. Joel stated that the RMMC has been allocated 52 delegates. At the time of this conference, less than 52 people have come forward indicating their desire to serve as a delegate. If there is no objection the office will accept and approve all who meet the criteria and express a desire to serve as a delegate. In addition, the mission center office will continue to accumulate the names of those who wish to serve as a delegate. When the full complement of 52 is met, we will continue to collect names with those in excess of 52 being listed as alternates. If any elected delegate is unable to serve, alternates will then become delegates in the order they were added to the list. If there is no objection, we will utilize this procedure to identify RMMC delegates to the 2023 world conference. No objections to this plan were presented.

Closing thoughts were expressed by Joel. He highly recommended that anyone not currently registered to attend the gathering the following weekend at the YMCA in Estes to contact the office and register to attend. Shirley Remmenga moved to adjourn this conference. A second was made and Joel declared this business meeting adjourned.

We were invited to bow in a spirit of community and thanksgiving as sister Monica Argotsinger offered the closing prayer.

- Expansion Fund: This fund is invested in the World Church investment pool and is used to fund approximately 50% of the Mission Center's operating expenses. The Presiding Bishopric has recommended an annual withdrawal rate of 4% to maintain the principle and adjust for the effects of inflation. A withdrawal rate of 4% would equal \$127,000, however, the proposed 2024 budget only includes \$124,300, as we intentionally plan to use a withdrawal rate lower than 4%.
- Youth Ministries Reserve: This includes any proceeds from fundraising events, the grocery card program income, any youth program grants from individuals and congregations, and utilizes the balance of the Youth Ministry Fund, to help with subsides and cover the costs of youth activities and events.
- **Ministerial Expense Fund:** A transfer to utilize the Ministerial Expenses Fund (previously named the Elder's Expenses Fund) to cover ministerial travel and expenses.
- Operating Reserves: This was additional funds (above the 4% rate) needed to be transferred to balance the budget. The 2024 budget balances without the need to transfer additional funds from operating reserves.

#### **Administrative Expenses**

- **Audit**: The amount in 2023 is higher than budgeted because we received bills for both 2020 and 2021 audits. World Church no longer provides someone to be our auditor, so we will be looking for someone new for 2023.
- Bank Fees: This line is associated with both banking fees and payroll processing fees.
- **Equipment Maintenance**: Includes maintenance of computers, copy machine, telephones, and other office equipment. This amount includes reserves for replacement.
- **Insurance**: This line includes general liability and workers compensation insurance. As always, premiums are likely to increase, so this line item has increased by \$800 for 2024.
- Communications: This line includes office phones, internet, website costs & Zoom fees. A significantly reduced rate has been secured for the office phone and internet, reducing the budgeted amount by \$4,000 in 2024.
- Office Salaries: This amount remains the same despite currently having one less employee in the office. More information will be provided later with regards to the bookkeeper position.

#### **Program Expenses**

- **Conferences and Meetings**: The cost of the Mission Center Conference and other programs during the year.
- Family and Adult Camps: Supplemental support of program costs.
- Family Assistance Reserve Savings: This was a new line added in 2023 to reduce a negative fund balance in the Family Assistance Fund. The fund is still running a negative balance, so an amount is included again in 2024.
- **Leadership Development**: Supplements the costs for individuals attending classes, seminars, and retreats.
- Young Adult Ministries, Youth Ministry Salary, and Youth Activities and Events: Provides general support for planning and producing youth and young adult programs.

#### **Ministerial Expenses**

- Ministerial Expense Reimbursement: Travel and other ministerial expenses.
- Ministerial Salaries: Mission Center ministerial salaries, benefits & 403b contributions.

Resolved, to amend the current Big Spruce By-Laws to add section 4.04.4 and change the wording of the final sentence for Section 5.02. Those sections would read as:

#### **Section 4.04.4 TERM OF OFFICE**

The term limits applicable to an Elected Director under Section 4.04.2 may be suspended as to a particular term-limited Elected Director ("Term-Limited Director") if the Board of Directors determines, by a two-thirds vote, that either:

- 1. Due to the Term-Limited Director's skills, knowledge, and/or expertise, it would be in the best interest of the Campground to allow the Term-Limited Director to be eligible for reelection for another term; or
- 2. there are insufficient qualified nominees to fill all upcoming Elected Director positions.

Upon such a determination by the Board, the Board may nominate a Term-Limited Director for election to an additional term for consideration and election by the Association Conference under Section 4.01.1. Any board determination under this section shall only be applicable to the named Term-Limited Director and shall have no effect on the term limits of any other Elected Director.

#### **Section 5.02: ELECTION OF OFFICERS**

Change the last sentence to the following:

Any officer may be re- elected to succeed themselves so long as they continue to hold office as either an Elected Director or Ex Officio Director on the Board of Directors.

#### Hello Friends of the RMMC,

It's hard to believe that it was this time last year that I was first being introduced to you as your new mission center president. Since that time, I have been blessed by many new friendships, opportunities for ministry, and a deep awareness that the Holy Spirit is inviting me, and us, to explore what it truly means to BE Community of Christ. In other words, what it means to full embody the name of our faith movement.

Before I continue with my reflections from this year, let me take a step back to explore that sacred nudge in my life that led me to this place. I had been sensing



that I was being prepared for a new responsibility in the life of the church for some time. In June 2022, while having dinner with Larry McGuire and Ron Harmon, I was asked where I saw myself serving next in full-time ministry. Our summer camping program events took place in other locations as well. In July our Rockies Delegation joined other youth and staff for

Spectacular at Graceland University in Lamoni, Iowa. Yet again, Melanie Grimes organized this amazing experience for us. While I still had responsibilities with my former delegation for one last time this past summer, I was still able to take in some delegation meetings and sports games with the Rockies Delegation. In addition to our amazing delegation staff, it was so good to see many more of our members from the RMMC volunteer in many ways at Spectacular. Then at the end of the July, we had our last camping event of the summer with Rockies Family Camp at



Snow Mountain Ranch in Granby, Colorado. Deep gratitude to Joel Cox for directing this reunion. It was so good having him and Jody with us. Counselor to the Presiding Bishop Carla Long and her two kids provided ministry for our reunion experience.

Earlier in the year we explored the theme of "Courage" through worships, business meetings, and other activities at the 2023 World Conference. It was so good to be back together again with

our church family from across the globe. The reality of the impact of COVID-19 on our experience was apparent as many tested positive during the week and upon returning home.
